Educational research workers of higher education institutions, research workers of scientific institutions, doctoral, PhD and postgraduate students are allowed to participate in the internship.

Organizer of the training on the topic “Innovative Educational Technologies: European Experience and Its Application in Training in Economics and Management” (Kielce, Poland) is KONSORCJUM NAUKOWO – EDUKACYJNE (KIELCE, POLAND), with the assistance of the WYŻSZA SZKOLA HUMANISTYCZNO EKONOMICZNA (BRZEG, POLAND) AND Black Sea Research Institute of Economy and Innovation (Odessa, Ukraine).

The internship is conducting without discontinuing work in accordance with the certificate in postgraduate education and distant education.

Internship programme includes: familiarization with the history of the KONSORCJUM and University development via the official information portal; familiarization with the variety of major specialties in the field of economics and management, as well as educational materials; preparation of the thesis of scientific methodological report on the chosen problem (work profile of the applicant); receiving collection of scientific reports and International Internship Certificate with the signature of the internship program supervisor.

All participants of the internship will be provided with a collection of theses of scientific and methodological reports, a certificate of scientific and pedagogical internship (in two languages).

Certificate of scientific and pedagogical internship is a document confirming the internship in a scientific institution in a country that is a member of the European Union, for the title of associate professor, professor and senior research fellow in accordance with paragraphs 2.1, 2.2, 2.3, 2.5, 2.7 of the Procedure scientific titles to scientific and scientific-pedagogical workers, and also is considered at licensing and accreditation of educational services.

The internship load without discontinuing work is 6 credits (180 hours) and is being distributed as follows:

- virtual tour via the official information portal of the University – 20 hours;
- virtual tour via the official information portal of the KONSORCJUM – 20 hours;
- familiarization with the variety of specialties in the field of economics and management, distance working system of the KONSORCJUM and University – 60 hours;
- preparation of the thesis of a scientific methodological report on the chosen problem (work profile of the participant) – 40 hours;
- individual work – 40 hours.

REGISTRATION FEE:

1. Registration fee of the internship participants is **150 EUR** expressed in UAH equivalent at the NBU exchange rate for the date of payment, and is used for reimbursement of transport and administrative costs on the preparation of international certificates, using the official information portal, publication of collection of the theses and its posting to participants. The certificate of the internship topic's conformity with the work profile of the participant (for participants with another field-specific education) is charged extra and the cost is **150 UAH**.

2. Please note that the **internship is one-person**.

3. Details for payment will be provided upon receipt of theses and applications. The authors need to transfer funds after the adoption of the theses of the report by the organizing committee.

4. Collection of the theses of scientific methodological reports and certificate will be send to participants to a postal address specified in an application up to **March 12, 2021**.

REQUIREMENTS FOR THESES:

Languages of report theses: Polish, Ukrainian, Russian, English.

- The length of the theses is up to 5 pages with paper size A4 in a text editor Microsoft Word for Windows 6.0, 7.0, 97, 2000, 2003, 2007; 2010;
- Font – Times New Roman, size – 14; line spacing – 1.5; indent – 1.25 cm; fields – 2 cm;
- Sequence of placement of materials in theses of the report: title of theses (capital letters, font - bold); author's surname and initials (font - bold); scientific degree, academic title (if any), position, affiliation; text;
- The file must be named in Ukrainian according to the name and initials of the participant (for example Stetsenko L.P._theses);
- The used literature (without repetitions) is made out at the end of the text under the name "Literature:" taking into account the National standard of Ukraine developed in 2015 DSTU 8302:2015 "Information and documentation. Bibliographic references. Generals and rules for assembly".

In the text, footnotes are indicated in square brackets with indication of the ordinal number of the source in the list and page numbers (pages) separated by a comma, for example: [5, p. 26].
